

I (Competitor) acknowledge that rodeo is a dangerous activity and that participation in a rodeo expose myself to a substantial and serious risk of personal injury. Being fully aware that such participation in rodeo events, I will be exposed to substantial and serious risk of personal injury or death, I hereby release the NRCA, its sponsors, rodeo committees, rodeo production entities, their affiliated related or subsidiary companies, and the officers, directors, employees and agents of such entities or organizations, from liability for any and all property damage, personal injuries, or other claims arising from participation in rodeo, including claims that are known and unknown, foreseen and unforeseen, future or contingent.

In consideration of being permitted to enter for any purpose any restricted are (here in defined including but not limited to the rodeo arena competition area, chutes, pens areas reserved and intended for participants or restricted to the general public, and all walkways, concessions, and other areas appurtenant to any area where any activity related to the event shall take place). or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, THE UNDERSIGNED, for themself, his personal representatives, heirs and next of kin. acknowledges. agrees, and represents that he has. or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgment that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted areas: 1 HEREBY RELEASES. WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE the participants, sanctioning organization or any subdivision thereof, rodeo committee, stock contractor, rodeo association, arena operators or owners, officials, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used 10 conduct the event and each of them, their officers and employees, undersigned, his personal representatives, assigns, heirs, and next of kin for any for the purposes herein referred to as "releasees". from all liability to the or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, all loss of damage, and any claim or demands therefore on account of injury to the person and/or, competing, officiating in, observing, working for, or for any purpose participating in the event: 2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted ares o in any way competing, officiating, observing, or working for, or for any purpose Parlscipating in the event and whether caused by the negligence of the releasees or otherwise 3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY



DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event. THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. THE UNDERSIGNED further expressly agrees that the foregoing release: waiver, and indemnity agreement is intended to be as broad and inclusive is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, as notwithstanding, continue in full legal force and effect. THE UNDERSIGNED consents to being photographed and/or videotaped during participation in any NRCA rodeo and consents to the use of those photographs or videotapes in the promotion of NRCA rodeo, including but not limited to their use in promotional literature and media. television, or other electronic media. Their release to print the undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement and further agrees that no oral representations or inducements apart from the foregoing written agreement have been made have read this document. I understand it is a release of all claims, I understand and I assume all risk inherent to rodeo. I voluntarily sign my name evidencing my acceptance of the above provisions.
